Course Description

This workshop will offer an in-depth clinical guide to the many advances in the diagnosis and management of migraine, cluster headache, tension-type headache, and atypical variants. It will provide the participants with a thorough overview of the diagnosis of the different primary headache disorders, and then explore the pathophysiology of migraine integrating neurochemical, physiological, behavioral, and psychological perspectives. The pharmacologic, psychophysiological, and behavioral treatment evidence-base along with new and emerging therapies will be reviewed. The course will help the biofeedback/neurofeedback therapist understand the basics of successful headache diagnosis and treatment, and better communicate with the medical community. Behavioral and psychophysiological protocols will be emphasized.

This workshop will also review clinical studies on paradoxical effects of overuse of immediate relief medications in relation to treatment outcome. Chronic migraine will be thoroughly examined including the transformation process from episodic to chronic headache. Issues of psychiatric co-morbidity will be explored in depth, including pharmacological and psychological treatment considerations. Essential issues in psychopharmacology including pharmacokinetics, pharmacodynamics, an overview of different medications across classes and diagnoses, and critical topics in psychopharmacology will also be examined.

Workshop Faculty

Steven M. Baskin PhD is co-director of Behavioral Medicine Services at The New England Institute for Neurology and Headache in Stamford, CT and is an attending psychologist at Greenwich Hospital of Yale-New Haven Health. He is also a medical (prescribing) psychologist at Crescent City Headache and Neurology in New Orleans. He had previously founded the Behavioral Medicine Service at the New England Center for Headache. Dr. Baskin is a past-president of the Association for Applied Psychophysiology and Biofeedback (AAPB) and is a current member of the Board of Directors of the Headache Cooperative of New England (HCNE). He is also the Educational Director for the Annual Fall HCNE Boston Headache Symposium. He is a past board member of the American Headache Society and an Associate Editor of the journal, *Headache*. Dr. Baskin lectures frequently at national and international meetings and has published extensively on primary headache disorders, most recently on comorbid psychiatric factors that may chronify migraine and complicate treatment.

Mark S. Schwartz, PhD is on the Emeritus Staff of the Mayo Clinic since retiring after 37 years on the staffs of Mayo Clinic Rochester and Mayo Clinic Florida. He chaired the section of Psychology at MCF from 1988 until his retirement in 2004. He is past Chairperson of the BCIA Board 1981-1983, on the BCIA Board from 1981 to 1986, and was President of the Biofeedback Society of America (now AAPB) in 1987. He was Speaker of the General Assembly of the National Commission for Health Certifying Agencies 1982 to 1985. Dr. Schwartz is Board Certified by the BCIA, a Diplomate in Clinical Sexology, and a Diplomate of the American Board of Assessment Psychology. He edited and wrote parts of *Biofeedback: A Practitioner's Guide* (Guilford Press) (1987) and the 2nd Edition (1995). He co-edited and wrote parts of the 3rd Edition (2003) and 4th Edition (2016) with Frank Andrasik, PhD. He was an Adjunct Professor of Psychology at the U. of North Florida from 2005 through 2010, and a Visiting Professor at UNF from 2012 to 2014. Dr. Schwartz is a pioneer in the field of applied psychophysiology and biofeedback and a long-time member of the Biofeedback Society of Florida. He is now in private practice at his home office in Jacksonville.
